CHAPTER 1, TITLE 5, AND TO AMEND § 22402 OF ARTICLE 4, CHAPTER 22, TITLE 5, ALL OF THE GUAM CODE ANNOTATED, RELATIVE TO ABOLISHING THE OFFICE OF CIVIL DEFENSE AND STRENGTHENING THE ADMINISTRATION OF EMERGENCY MANAGEMENT FUNCTIONS BY CREATING THE BUREAU OF EMERGENCY MANAGEMENT WITHIN THE GUAM FIRE DEPARTMENT AND ASSIGNING RESPONSIBILITIES THERETO.
